Who we are

Christian Copyright Licensing International (CCLI) was originally established in 1988 to provide a copyright solution for churches wanting to reproduce the words of hymns and worship songs.

As churches began to adopt new technology into their activities, CCLI responded to their needs and began to provide copyright cover to show films, play or perform music, record services, photocopy from authorised publications and now, with the increased usage of the Internet, legally download song lyrics and lead sheets.

CCLI became aware that other organisations needed permission from the copyright owners for their activities and were able to offer licences to schools, events, Christian bookshops and many others.

CCLI is able to offer practical advice and support through the maze of copyright. With systems in place to ensure that copyright owners are fairly rewarded for their work, CCLI has become highly respected among the copyright organisations around today.

CCLI licences are available in Australia, Belgium, Botswana, Brazil, Canada, Denmark, Ireland, Faroe Islands, Finland, Germany, Iceland, Lesotho, Luxemburg, Malawi, Namibia, New Zealand, The Netherlands, Norway, Singapore, South Africa, Swaziland, Sweden, Switzerland, the United Kingdom, the United States, Zambia, Zimbabwe.

The licences we offer in Europe are:

- The Church Copyright Licence (CCL): The CCL was designed for churches who wish to print song sheets or hymnbook supplements, store lyrics on a computer for use with projection systems, or audio/video record music from their services. In order to do this, churches would need direct permission from the copyright owners, so to simplify matters, CCLI introduced the Church Copyright Licence, which ensures copyright owners are properly rewarded for the use of their work and giving churches the freedom to use songs without having to contact many different copyright owners. Over 43,000 churches and schools in Europe now hold a CCL, making it one of the most widely used worship resources.
- SongSelect®: SongSelect was created to allow easy and legal internet access to the words and music of thousands of popular hymns and worship songs, to be used during worship groups and services. SongSelect is an online resource to download song lyrics, listen to sound samples, download chord and leadsheets and listen to melody lines using the online player.
- The Church Video Licence (CVL) : The CVL was designed for churches who wish to show film scenes during sermons or in discussion groups, or churches who wish to show films for outreach purposes, as DVDs available for purchase and hire are not normally intended for public viewing.
