



## Caring for Creation

# Towards Net Zero Carbon Programme of Activity – phase 2 (2024-2026)

Diocese in Europe May 2024

#### **Summary**

In 2022, the Diocese in Europe's environment policy was updated as a Caring for Creation policy and a specific section on working towards net zero carbon was included. The first phase of a 'Towards Net Zero Programme of Activity' was developed to guide the Diocese in its contribution towards the Church of England's goal of net zero carbon by 2030.

This document - phase 2 of the Programme of Activity – provides direction to the Diocese for activities in 2024-2026, with the aim of fulfilling the milestones in the national routemap towards net zero carbon, focussed largely on buildings and travel emissions.

After explanatory notes on context, scope, challenges & enablers, and oversight; the programme lays out activities which need to take place at Diocese, Chaplaincy and Archdeaconry level.

- The focus of activities for chaplaincies remains as per phase 1. Reducing energy emissions by switching to green tariffs, using energy efficiency lighting etc, is paired with measuring building and travel footprints, planning for improvements and working with the EcoChurch programme.
- Diocesan activities, now also supported by Net Zero Officer, have been expanded to increase the support available to chaplaincies and to fit with national routemap milestones
- Providing ongoing support at Archdeaconry level, through Archdeaconry Environment Officers, networking of Local Environment Officers and training opportunities remains an important feature of the Diocese approach.

We will need to continue efforts to collect and use data in order to identify priority areas for improvement and to track progress.

By the end of phase 2, we hope to have evidence of reduced emissions from energy use and work-related travel, to have a strong network of LEOs supporting climate and environment action in chaplaincies across the Diocese, to have undertaken energy audits and embarked upon relevant buildings improvements in priority cases, and to be more widely engaged in the EcoChurch programme.





This area of work remains challenging but of great urgency and an important part of our discipleship.

#### Context

In February 2020 the Church of England General Synod set a goal for the Church to reach net zero carbon emissions<sup>1</sup> by 2030.

The Motion stated That this Synod, recognising that the global climate emergency is a crisis for God's creation, and a fundamental injustice,

- . call upon all parts of the Church of England, including parishes, BMOs [Bishop Mission Orders], education institutions, dioceses, cathedrals, and the NCIs [National Church Institutions], to work to achieve year-on-year reductions in emissions and urgently examine what would be required to reach net zero emissions by 2030 in order that a plan of action can be drawn up to achieve that target;
- (b) request reports on progress from the Environment Working Group and the NCI's every three years beginning in 2022 and;
- (c) call on each Diocesan Synod, and cathedral Chapter, to address progress toward net zero emissions every three years.

The Diocese in Europe addressed the challenge of Caring for Creation in detail at its Synod in 2018 and chaplaincies have worked hard towards becoming Eco Churches.

At Diocesan Synod in December 2021 the work of the Net Zero Working Group was endorsed in a debate which ended with the unanimous approval for this motion: *This Synod pledges to devise and promote a programme of activity across the Diocese so that the Diocese in Europe is in line with the General Synod's pledge 'to work to achieve year-on-year reductions in emissions and urgently examine what would be required to reach net zero emissions by 2030'.* This work to be led by the Net Carbon Neutral Working Group and reported to Diocesan Synod in June 2022.

In June 2022 the Diocesan Synod approved an update to the Caring for Creation policy (formerly the Environment Policy), including a section on working towards Net Zero. The Net Zero Working Group presented the first phase (2022-2024) of the Towards Net Zero Programme of Activity. The group subsequently became the 'Caring for Creation' Working Group.

As per April 2024, 13 chaplaincies have achieved the bronze award from A Rocha, and 4 silver, and the Diocese has also been awarded Bronze Diocese status.

The Church of England General Synod has recently approved actions in response to the biodiversity crisis. As this strengthened commitment to biodiversity becomes integrated into policy and

<sup>1</sup> For the Church of England, being net zero carbon means that the carbon emissions of our buildings and travel will be reduced to less than 10 per cent of our baseline levels. The remaining emissions will be offset in verified schemes that reduce carbon. That means overall, our buildings and travel will not contribute to rising carbon emissions: their contribution will be 'net zero'. Responding to the climate crisis is an essential part of our responsibility to safeguard God's creation and achieve a just world.





guidance, this will further strengthen our holistic approach to Caring for Creation, especially underpinning targets and action within this Programme of Activity towards Eco-Church awards.





#### Overview -

The Diocese in Europe supports and contributes to the Church of England goal of net zero carbon by 2030.

The activity programme draws upon the areas of action and milestones in the National Routemap<sup>2</sup>).

Phase one Programme of Activity contained key activities for the period 2022-2024.

Phase two has been updated to cover 2024-2026. Many activities either remain relevant or are not yet complete, and have therefore been extended into phase two.

Additional targets, areas of action and activities are expected to be added in future phases.

The programme of activity contributes to the realisation of the Caring for Creation Policy.

#### Scope

The Church of England national Environment Working Group have developed a definition of what is in scope for the net zero carbon 2030 target and this was updated in September 2020 after national consultation. The key activity areas to be addressed in net zero carbon 2030 scope as defined by the Church of England are energy use in buildings, and work-related travel.

The programme of activity for the Diocese in Europe follows this lead in having its main focus on these same areas. However, as more information is gathered on relative areas of activity and carbon footprint in the Diocese, it is expected this scope may be expanded in future plans.

It is noted that while lifestyle-related carbon emissions are not currently included in the nationally defined scope for the church's net zero carbon 2030 target, (and not a primary focus of the Diocesan programme below) this is an area where it is vital to support each other on our common and faithled journey. The Eco-Church programme is a particularly useful framework to enable congregations to engage with lifestyle issues more closely.

#### **Obstacles & challenges**

The following challenges were identified before programme development in 2022:

Challenge identified 2022:	Comment in 2024 as we enter Phase 2:

-Resources - financial resources, expertise, and human resources will be required, difficult to quantify on a Diocesan level	Financial support from central funds secured to support employment of Net Zero Officer and some starter funding. But further funding will be required going forward.
-Competing agendas - chaplaincies are faced with many requirements and important issues; alongside which the urgency of reducing carbon footprint needs to be addressed	The risk of 'overload' remains real – hence efforts to provide advice, tools, and to build network of engaged volunteers.

The Diocese in Europe also has some specific characteristics compared to dioceses in England in working towards net-zero carbon. These include:

- Relatively low 'ownership' of buildings, with many chaplaincies sharing and/or renting premises (church, offices, accommodation etc) – meaning that chaplaincies may have little control over buildings-related decisions.
- Diversity of national contexts, including availability of energy alternatives, national standards etc.
- Distance wide geographical spread with low density of churches results in high travel requirements for church representatives and congregation members.

These characteristics have been recognised by the National Church, and continue to inform the Diocese's approach to working towards net-zero carbon as per the updated programme of activity.

#### **Facilitators & enablers**

The following factors were identified as supporting the Diocese in its activities towards net zero carbon milestones -

#### Measurement and oversight

Progress on the programme of activity is reported regularly to Synod and Bishop's Council and updated on an annual basis to reflect improved information, resources available and continuous improvement.

The Caring for Creation Working Group makes proposals to the Bishop's Council related to the programme of activity, and means to implement it.

The House of Laity and House of Clergy of the Diocesan Synod are each represented in the Working Group.

Although data collection has been initiated, at the start of phase 2 there is still insufficient data to determine a complete range of targets for emissions reduction (and therefore to what extent offsetting may eventually be required).

Data collection is therefore an important and continued effort alongside engagement in activities which clearly contribute towards net zero carbon.

<u>Note:</u> due to lack of data, some reductions in emissions may be hidden (and will remain hidden) due to the absence of a baseline. For example, many chaplaincies are already engaging with efforts to reduce energy consumption. In the absence of the 'before' data showing original energy consumption, this reduction will not appear in the Diocesan reporting. We have a long way to go towards net zero carbon—but we may have already made progress that is not visible!



# **Towards Net Zero Carbon Programme of Activity – 2024-2026**

**1- Diocese** This section contains activities to be carried out by Diocesan bodies in order to support the work towards net zero carbon across the Diocese. Items 1 to 5 are continued from phase one, 6 & 7 are extended and 8 to 10 are new additions to the programme.

**3- Archdeaconries** — this level of activity does not correspond directly to targets /actions on the National Routemap, but was developed specifically to deal with the unique situation in the Diocese in Europe. Networking, discussion, guidance and exchange at archdeaconry (and in some cases deanery)-level is an essential means of support for chaplaincies working towards net zero carbon, given the size of the Diocese and the varying geographical/national contexts.

## 4-Governance and support for net zero programme of activities

The Net Zero Working Group (NZWG) is now the Caring for Creation Working Group (C4C WG). The group meets regularly to support implementation and review of the programme of activity, including through development and sharing of relevant tools and resources.

The C4C WG includes Diocesan Synod representatives (clergy and lay), and reports to Bishop's Council on a regular basis. Bishop's Council and Synod will consider reports on progress in implementing this programme of activities and will adopt recommendations as necessary to facilitate achievement of the targets.

Archdeaconry Environment Officers will meet with Caring for Creation Working Group as an 'extended group' formation every quarter, to facilitate sharing to and feedback from Archdeaconries.
